

HPQ Files Annual Financial Disclosure

Montreal, Canada, May 2th, 2025 — <u>HPQ Silicon Inc.</u> ("HPQ" or the "Company") (<u>TSX-V: HPQ</u>, <u>OTCQB: HPQFF</u>, <u>FRA: O08</u>), a technology company developing next-generation processes for advanced material manufacturing announces that, further to its April 30th release, the Company has filed today its audited annual financial statements, management's discussion and analysis and related CEO and CFO certifications for the financial year ended December 31, 2024 (the "Required Filings").

Because of the urgency of the situation and because we are a Quebec-based Company, the Required Filing was done in French to satisfy the requirement of our primary regulator, *Quebec L'Autorité des Marchés Financiers (AMF)*. The English version of the documents will be filed as soon as it is practical.

Having completed the filing, the Company will now focus on submitting a formal reply to the AMF's inquiries and getting the temporary Cease Trading Order (CTO) lifted.

The Corporation confirms that no proceedings against it exist as of the date of this press release and that no other material information concerning its affairs has not been generally disclosed as of the date of this press release.

HPQ Silicon Inc. (TSX-V: HPQ) is a Quebec-based TSX Venture Exchange Tier 1 Industrial Issuer.

HPQ is developing, with the support of world-class technology partners <u>PyroGenesis Canada Inc.</u> and <u>NOVACIUM SAS</u>, new green processes crucial to make the critical materials needed to reach net zero emissions.

HPQ activities are centred around the following five (5) pillars:

- Becoming a green low-cost (Capex and Opex) manufacturer of Fumed Silica using the FUMED SILICA REACTOR, a proprietary technology owned by HPQ Silica Polvere Inc being developed for HSPI by PyroGenesis.

- 3) HPQ SILICON affiliate NOVACIUM SAS is developing a low carbon, chemical based on demand and high-pressure autonomous hydrogen production system.
- 4) HPQ SILICON affiliate NOVACIUM SAS is developing a new process to transform black aluminium dross into a valuable resource.
- 5) Becoming a zero CO₂ low-cost (Capex and Opex) producer of High Purity Silicon (2N+ to 4N) using our *PUREVAPTM "Quartz Reduction Reactors" (QRR)*, a proprietary technology owned by HPQ being developed for HPQ by PyroGenesis.
